5. <u>DELEGATIONS</u>

Mr. Mike Redcliffe shared photos of his greenhouse with Committee and provided information about the growing season, how he constructed it, and the success of his crops. The greenhouse is a wood frame that is covered by a single sheet of vapour barrier plastic

that is designed to withstand 18 inches of snow. Plants such as beans, peas, strawberries and peppers can be grown and harvested into early October. The Committee asked Mr. M. Redcliffe various questions about heating, irrigation, growing season, and ventilation. Various methods for heating greenhouses were discussed, including constructing in-ground greenhouses, walls covered with dark containers of water to hold heat, etc. Cllr. J. Timpson asked Mr. M. Redcliffe he would consent to being featured on the Environment Committee's Facebook page; Mr. M. Redcliffe said he would be interested and so the Committee will follow up with him, Mr. G. Hoggarth thanked Mr. M. Redcliffe for attending and sharing.

6. BUSINESS ARISING FROM PREVIOUS MINUTES

- Ms. Y. Schreiber to report on potential to incorporate COP26 recommendations into the 2022 work plan. Ms. Y. Schreiber looked at COP themes and stated that a lot are being hit by what were currently doing. The main COP themes were energy, financial commitments, and transportation; these themes were then discussed in terms of mitigation, reducing emissions, adaptations, helping those in need and who will be impacted, and financing climate goals. The Committee and Municipality could work on items related to energy, deforestation/land protection, greener transportation options, and reducing waste and emissions. Ms. Y. Schreiver also commented on engaging youth and the public with goals of being inclusive and empowering residents. Cllr. J. Cassidy noted that some of our environmental context is unique and that should be considered, such as how forests can be regenerated by fire or by planned harvesting. All communities are different and must seriously consider our unique context along with both pros and cons. Mr. G. Hoggarth noted that it can be hard to assess information, and that providing both pros and cons is helpful. Ms. Y. Schreiber will write up a brief about COP26 so that members can refer to it over the year while looking at the work plan and projects. She will also look for additional resources.

- iii. Facebook page updates

Cllr. J. Timpson reached out to Mr. B. MacKinnon about setting up an Environment Committee Facebook page that was connected to the Municipality's Facebook page. Mr. C. Pollard helped set the new public page up. The Committee has the power to edit, remove, control and share content. Launching the page was discussed. Creating an introductory post to introduce the page that lays out rules and such was discussed. Determining how often to post and how to attract people to the page was questioned. Ms. A. Saltel stated that she joined the page and was willing to help administer the page. The Committee

discussed advertising the page through other Sioux Lookout pages and groups. The details of the page's administration need to be confirmed with Mr. C. Pollard, including whether the public can post on the page without approval or not. Ms. Y. Schreiber suggested including a list of resources, engaging and inspiring content, as well as introducing the Committee Members the Committee agreed that introductions would be a good idea. Cllr. J. Cassidy asked if this page is to take place of resources posted on the Municipal website. Mr. G. Hoggarth and Ms. Y. Schreiber expressed that they feel it should run parallel with the Municipal website so as to provide information in as many accessible forms as possible. The Committee discussed whether to start posting on the page immediately or create a subcommittee that would create a sort of 'business plan' to address some of the questions and prepare for full-scale launch of the page. The Committee decided that they will form an Environment Committee Facebook page subcommittee comprised of Ms. Y. Schreiber, Ms. J. Jones, Ms. A. Saltel and Cllr. J. Timpson. Ms. Y. Schreiber suggested involving a student to help. Mr. G. Hoggarth liked that idea and suggested reaching out to some high school teachers to recruit a student.

Minor change made to task regarding sharing produce to allow for exploration of multiple activities alongside gleaning.

Discussion: The Committee discussed encouraging changes in garbage pickup to require garbage be placed in clear plastic bags when put out for pickup, where garbage bags are then examined for recyclable objects and refused for pickup if recyclable objects are included with garbage. Mr. Hoggarth and Ms. Saltel noted that when the issue of requiring clear plastic garbage bags

was brought up years ago, a major concern by residents was privacy. Mr. Van Horne noted that the Committee should be focused on trying to reach people who aren't currently recycling rather than those who try but make minor mistakes, as that is the better "bang for the buck" in reducing recyclables going to the landfill. Task was added related to this goal.

Discussion: To relate to goals presented at the COP26 talks, the Committee discussed encouraging growing native plants. The Committee also decided to broaden scope from 'bee friendly' to pollinator friendly. Name of section and goal was subsequently added to incorporate these ideas. The Committee agreed that discussions should be had with the new Recreation and Culture Manager regarding the goals in this section related to Municipal property; this will be accomplished through the Staff Resource, Mr. Brinkman.
