**Summary of Inaugural meeting of Sioux Lookout Green Team
Council Chambers
29 March 2023**

5:00 pm

Present: From the public: Merle Berkeholder, Edith Berkeholder, Susan Hochstedler, Bill Hochstedler, Corrine Sever, Karl Friesen, Jennifer Hancharuk (also member of Environment Committee)

From the Municipality: Cllr Joyce Timpson, Cllr Reece Van Breda, Komal Shah

Regrets: Cathy Carpenter (who sent several pages of comment via Jennifer Hancharuk)

Joyce welcomed the attendees and introduced herself and Reece Van Breda and reviewed general reasons for the meeting., namely, the Environment Committee of Council wishes to honour and support citizens who regularly collect garbage on their own and look at with them ways we might be able to address the larger problem.

Reece opened the meeting and began with attendees introducing themselves and describing their efforts in cleaning up litter. Some have been doing this for decades. Before we completed the round table introductions, enthused discussions occurred with notes taken, recommendations made. People are very passionate about the need for a clean town and expressed frustration with those who litter and the extent of the littering.

The following are highlights of points made in the discussion categorized thematically:

Issues to assist citizen Litter Collectors

- What to do with garbage they collect? They should not have to pay for disposal
- How to get more people collecting garbage
- Get high school students involved to get volunteer hours
- Other persons Interested: Cathy Carpenter, Randy Hendrickson, Lawrence Durante, Lew Morgan
- Picker-uppers needed
- Group not interested in T-shirts as they have enough “stuff”
- Have rewards to those for picking up garbage such as a free bag tag, reward such as package of chicken wings as done in Pickle Lake
- Supply collectors with garbage bags, and have method of disposal so they do not have to pay

Public campaign to Stop Littering

- Messaging Example: Take pride in your community, Take pride in your land, or Respect your community, Respect your land...
- Place Ads on places like Hub Transit buses
- Ask businesses to put Ads on windows

Enforcement Measures

- By-law officer needs to be on side. The littering by-law needs teeth. Now it is complaint driven and by-law officer needs to see some violating the law
- OPP and MNR need to be involved. Someone reported being stopped by OPP with back of trunk open driving slowing picking up litter
- Look at by law about securing garbage bags in trucks
- Have a Phone # to call for complaints about littering, “Litter Hotline”

Garbage Disposal Mechanisms

- Garbage disposal needs to be easier
- Garbage cans need to be at the schools
- Need more garbage cans
- Town needs to collect garbage from these cans more frequently
- 1st Ave has no garbage can at all
- Cans need to be emptied more often as they get full. A new design is also needed so garbage does not bulge out and fall out
- A sign for the landfill is necessary on the east side of King St/Alcona drive

Role of Town

- Getting town to pick up “rogue” (Joyce’s term) garbage such as stuff that falls off a truck and is left
- Getting town employees to pick up garbage before mowing the grass
- Street cleaner need to be used more (PW)
- Put ads on Handi Transit bus, (TOWN)
- Vacuum street cleaner should be used more
- ATV cleaner

General

- Clean up should be an all year round endeavour not just in Spring
- Simply asking people not to litter versus consequences for doing so, asking is not enough.
- How do we make it unacceptable to litter?
- One member was concerned that is he tells a First Nation’s person not to litter, he is seen as racist
- We need to keep cleaning up after people but work towards making it unacceptable to litter.

Decisions

- Group seemed interested in pursuing Green Team idea but did not want to bother with T-shirts.
- We did not make a decision about April 22nd Earth Day as several people will be away.
- Group had picture taken by Komal for newspaper. Joyce will write an article for the Bulletin to be in just before Earth Day and include the picture
- Will take recommendations from meeting back to Environment Committee
- Group will meet again and possibly wait until Chamber of Commerce announces its Spring Clean-up campaign.
- We will get Picker Uppers bought by Environment Committee to those who need one
- Have as a motto ”Respect the community. Respect the land”

RECOMMENDATIONS/DIRECTIONS

1. Support volunteer garbage collectors by:
 - a. supplying each individual a Picker-Up’r if required;

- b. develop a structure whereby Collectors can pick up garbage bags free from municipality; and can deposit garbage for free disposal of garbage collected.
2. Make garbage disposal easier for the public by:
 - a. Collecting garbage from public garbage cans more frequently so they do not overflow;
 - b. Installing garbage cans at the schools;
 - c. Putting garbage cans on First Avenue;
 - d. Looking at new design of garbage and re-cycle cans
 - e. Place wayfare sign for landfill site at east side of King St (Alcona Drive) past by-pass.
3. Make littering NOT acceptable:
 - a. Design an ad campaign with ad posters placed on Hub Transit, businesses etc;
 - b. Do article for Bulletin for edition before Earth Day;
 - c. Message: Focus on Respect, “Respect your community, Respect the land”;
 - d. Enforce by-laws against littering.
4. Municipal staff and involvement of others:
 - a. Engage by-law officer in campaign and adjust by-law as necessary to be more enforceable;
 - b. Engage Public Works to look at town picking up garbage that has fallen off trucks, picking up garbage before mowing grass, using the street cleaner more, and acquiring better equipment for street garbage clearance;
 - c. Engage OPP and MNR in ant-littering strategies.

- Ms. Saltel invited Mr. Doug Vinkle for discussion about preventing bikes from ending up in the landfill. Mr. Vinkle is concerned about reusable bikes which goes

in to the landfill. The Committee is disappointed with the number of bicycles ending up in the landfill, and discussed how to prevent this. Mr. Vinkle suggested sharing information on the Curbside Swap page on Facebook, and advised refurbishing bikes. After refurbishing, the bikes may be able to be sent to Northern communities.

- Ms. Saltel pointed out High school students in other places fix bikes and give away to people in need. She added that Committee members can share information on the Environment committee Facebook page as well.
- Mr. Vinkle explain about that the efforts it takes to refurbish a bike.
- Ms. Jones advertising about unused bikes in the newspaper, and gathering people to do some activity with the bikes.
- Mr. Hoggarth agreed about promoting the reuse of bikes through the Curbside swap program, and highlighting bikes on the Facebook page, which will help encourage people to not take unwanted bikes to the landfill.
