**7. DELEGATION/PRESENTATIONS/COMMITTEE PRESENTATIONS**

**Community Policing Update – Inspector Karl Duewel for Constable Andrea Degagne**

Inspector Duewel advised that Constable Degagne is on a 3 month Acting Sergeant assignment in Pickle Lake. She will be keeping some of her Community Policing duties in Sioux Lookout while on assignment, but the duties she is not keeping have been divided up between the other officers at the detachment for the duration of her assignment.

**Community Safety Team – Inspector Karl Duewel for Constable Jacob Gardam & Constable Lucas Wolfe**

Inspector Duewel advised that they would not be continuing with a dedicated Community Safety Team at the detachment. They will however divide the duties of the team between the junior officers that have started at the detachment.

Constable Gardam will be transferring to the Thunder Bay detachment.

**8. ITEMS FOR DISCUSSION**

**a) 3<sup>rd</sup> Quarter Statistics – Inspector Karl Duewel**

Inspector Duewel reviewed the statistics in the report and some highlight were:

- There have been no Public Complaints for the 3<sup>rd</sup> quarter;
- Marine patrol hours increased this Summer;
- Bike patrol hours were at 10 hours for the third quarter;
- Foot patrol hours were at 75 hours for the third quarter;



- Violent crime and Sexual Assaults are on a downward trend for the third quarter;
  - Inspector Duewel attributes this to the LCBO being closed Sundays and Mondays and an other business being closed;
  - Staff Sergeant Kreiszi started a Sexual Assault Task Force this year. They have been doing a lot of educational work in the community, as well as supporting the victims of sexual assault. This Task Force has contributed to the downward trend of the sexual assaults.
- Break and Enters were higher this quarter, but most of them were on the lower end thefts
- The Community Drug Officer had a high profile case this Summer. It resulted in several arrests
- Clearance rates are down for this quarter
- Calls for Service are trending the same as last year
- The Festive R.I.D.E. program will start on November 17<sup>th</sup>

**b) Remember Adam Resolution – Michelle Larose**

Michelle Larose asked the Police Services Board if they would like to support the initiative.

Mayor Lawrance advised that he would like more information about the initiative before having this brought forward to Council.

- Michelle will reach out to the East Ferris Police Services Board to gather the information and bring it back to the next Police Services Board meeting for review.

Inspector Duewel advised that they do not get many calls about people not stopping for school buses at the detachment.
