


PROVINCIAL OFFENCES ACT

| 12 | Fail to comply with an order dated () to take and supply test and samples | 36.-(1)(b) | \$100.00 |
| 13 | Remove copy of an order posted or obstruct the visibility of an order | 20 | \$100.00 |
