TAKE NOTICE THAT an application for Consent has been submitted under Section 53 of the *Planning Act*, R.S.O. 1990, Chapter p. 13, as amended, by Heather Coulson for the subject lands locally described as 3242 Highway 642 in the Municipality of Sioux Lookout. The subject lands are shown in the Key Maps below.

The subject lands have a lot area of approximately 36 hectares (89 acres) and have a lot frontage of 413 metres on Highway 642. The subject lands are currently contain an existing single detached dwelling.

The purpose and effect of the Consent application is to re-create three (3) lots on the subject lands that inadvertently merged, for a total of four (4) lots. This would re-create the previous lot layout that existed prior to the lots inadvertently merging. 
